	6	<p>Tax on income computed—Income computed under this Schedule shall be chargeable to tax under the head "Income from Business" and tax payable thereon shall be computed at the rate applicable in Division II of Part I of the First Schedule. The income under the head "Dividend" and "Capital Gains" on sale of shares of listed companies" shall be taxed at the rate of ten per cent:</p> <p>Provided that where the shares of listed companies are disposed of within one year of the date of acquisition, the gain shall be taxed at the rate provided in Division II of Part I of the First Schedule</p> <p>Provided further that the "Dividend" received by a banking company from its asset management company shall be taxed at the rate of 20%.</p> <p>Provided also that the dividend received from Money Market Funds and Income Funds shall be taxed at the rate of 25% for tax year 2013 and at the rate of 35% for tax years 2014 and onwards.</p>
