880	1 st Sep, 2007	Exemption of diagnostic kits or equipment.
76	23 rd Jan, 2008	Exempt the whole of sales tax chargeable on the supplies made by manufacturers of marble and granite having annual turnover less than five million rupees even if their annual electricity bill is more than six hundred thousand rupees.
408	19 th April, 2012	Exemption from whole of the sales tax chargeable on Blood Bag CPDA-1 with blood transfusion set pack in Aluminum foil with set.

460	30 th May, 2013	Supersession of SRO 280(I)/2013 dated 04-04-2013 to rationalize the rate and categories of Mobile Phone or Settelite Phones along with re-imposition of RS 250 on every new sale or activation of SIM Cards.
657	11 th July, 2013	Sales Tax at the rate of 5% shall be charged and collected on import and local supply of second hand and worn clothing falling under PCT heading NO. 6309.0000.
572	26 th Jun, 2014	Supersession of Notification No. S.R.O. 79(I)/2012, dated the 2nd February, 2012, the Federal Government is pleased to direct that sales tax shall be charged on the import or supply of agricultural tractors falling under PCT Heading 8701.9020 at the rate of ten per cent.
84	28 th Jan, 2015	Exempt from payment of whole of sales tax on the import and supply of raw material for the basic manufacture of pharmaceutical active ingredients and for manufacture of pharmaceutical products, falling in respective beading of the first Schedule to the Customs Act, 1969 (IV of 1969), provided that in case of import, only such raw materials shall be entitled to exemption which are liable to customs duty not exceeding ten percent ad valorem under the Fifth Schedule.
